I support Proposition 4 on the November 2026 ballot and urge all elected officials to help it pass.

The amount of money in politics is outrageous and is corrupting our democracy. Public financing of campaigns empowers voters and allows qualified candidates to compete with corporate special interests. But it is banned in California except in charter cities.

Proposition 4 will: (1) Allow public funding. (2) Require that publicly funded candidates abide by expenditure limits and meet strict criteria to qualify. (3) Prohibit use of public funds to pay for legal defense, fines, or to repay personal loans to campaigns.
